

BOYD COUNTY EXTENSION FRANKS COMMUNITY BUILDING

Guidelines for Making Reservations

1. Reservations will be kept by the Boyd County Extension Service secretarial staff. Forms are available at the Extension Office.
2. Scheduling will be done on a first-come/first-served basis with the County Extension Service receiving priority. *(See definitions of user groups.)*
3. No reservations for groups or organizations outside Boyd County Extension shall be accepted more than two months (60 days) in advance.
4. All requests for the use of the conference facilities are to be submitted on the appropriate forms. Forms may be obtained from the Extension Office during business hours. **Telephone reservations will be held for 48 hours pending receipt of deposit (if required) and reservation form. Damage deposit of \$100 is due within 48 hours of approval.**
5. Persons obtaining reservation must be 21 years of age or older and will be responsible for group's conduct and respect for facility. Any groups who abuse facility or violate rules and regulations will not be allowed to reserve the facility again. Charges for damages will be assessed.
6. Outside user groups may provide their own audio/visual equipment. Additional charge to use Franks system. *(see page 4 of guidelines.)*
7. Unless the kitchen is being reserved, user will have to provide own ice.
8. All Boyd County Extension Offices are closed from noon December 24 through January 1.

RULES

1. Room reservations may not be transferred, assigned, or sublet.
2. The Extension agents, or duly authorized representative on duty, shall have the right to enter all facilities, at all times during any and all occupancies.
3. The person making the reservation shall observe, obey and comply with all applicable city, county, state, and federal laws, rules and regulations. All permits and licenses required for the intended use under terms of this policy shall be procured by the reservation applicant *(health permits, etc.)*
4. The Boyd County Extension Council/District Board is not responsible for accidents, injury, illness, or loss of group or individual property. The Boyd County Extension Council/District Board may require proof of insurance coverage at a county approved limit where the activity for which the reservation is sought involves food or is inherently hazardous to life or property.
5. Reservation is **ONLY** for the time stated on application form. Time for setup and cleanup should be allowed in the reservation request. Please do not expect to use facility before or after the time stated on reservation. All members of the group must leave by the time reservation expires. Building must be vacated by 9:30 PM, except for special events or meetings. Special events or meetings that will meet beyond 9:30 PM will be so designated on the reservation form.
6. All persons using the Extension facilities shall be properly clothed. Shirts and shoes are required.
7. Do not scoot, pull or drag tables or chairs on the carpet or tile floors. Pick up chairs and tables when they need to be moved.
8. **Telephone messages:** If you leave the Boyd County Extension phone number for emergency calls, please check for messages during breaks.
9. The building is a non-tobacco facility.
10. Illegal drugs and alcohol are not allowed in the building or on the premises. Intoxicated persons are not permitted on the premises.

11. Weapons shall not be allowed in the building or on the premises (exceptions may be made for special projects such as 4-H Shooting Sports, Hunter Safety Courses, or similar educational activities.) No concealed weapons will be allowed and **under no circumstances will ammunition be allowed.** **No flammable materials and hazardous chemicals are allowed** (exceptions may be made for special projects).
12. No decorations, charts, posters, etc. may be attached to the walls, facings or doors.
13. Upon arrival, user needs to inspect building and duly note any irregularities. Please contact agent responsible for your group. Any user damaging property or equipment is responsible for the cost of the repair or replacement. All repairs will be arranged by Extension personnel. Extension personnel and noted representative will access building after use.
14. Meeting room users are responsible for leaving the room in the condition it was found. Cleaning charges may be assessed to any group by the facility committee at the rate of \$30.00 for the first hour and \$15.00 each additional hour.
15. Age groups, 18 and under, must be supervised by one adult for each ten present at all times while they are using the facility. The reservation must be made by one of the adults supervising the function.
16. Only use trash cans with plastic bag liners. If you have put food in the trash can, place it in the outside garbage container at the rear of the building.
17. Scrub the sink after use, especially when pouring leftover coffee into the sink. This eliminates stains. Wash and dry the coffee pot.
18. If serving food or beverage, use your own utensils and paper products.
19. Wipe tables and counters free of food products. Do not leave any food products in the refrigerator.
20. Sweep mud, crumbs, etc. from the foyer and meeting rooms if carried in by the group. Dust mops are located in the janitor's closet.
21. Leave tables and chairs in place. Room dividers are to be moved **only** by Extension personnel.
22. Extension Agent, Staff Member, Custodian or designated kitchen overseer or sound technician must be responsible for picking up a key and for securing the building after the event. Only the front door key may be issued to extension organization president or other officer. This person will be responsible for security.
23. Any person or persons violating the established rules and regulations, or constituting a public nuisance, will be asked to leave the facility, and will not be allowed to use the building again for one year. The custodian or staff will notify the facility committee in the event of damages.
24. The Boyd County Cooperative Extension Office does not discriminate on the basis of race, color, national origin, sex, religion, age, or handicapped status in the provision of services.
25. No equipment or furniture may be removed from the building for any reason.
26. Room capacity should not exceed the number posted by the Fire Marshall.
27. If room temperature needs to be adjusted, contact Extension Agent or Custodian to adjust temperature control.

Policies Regarding Use of Public Meeting Rooms August 2008

Policies and fees are subject to periodic evaluation by the County Extension Council and Extension staff.

The policies described herein apply to the **public meeting rooms** of the Boyd County Cooperative Extension Franks Community Building located at 1758 Addington Road, Ashland KY. **The policies are set by the County Extension Council. Please support these guidelines by refraining from asking for exceptions for your group.**

DEFINITION OF USER GROUPS

I. Boyd County Cooperative Extension Groups

First priority users (*Extension Council and all county groups that relate directly to the council: District Board, 4-H Council, Homemaker Council, Agriculture advisory and commodity groups, 4-H and Homemaker Clubs, Master Gardeners, Community Development Clubs, program workshops, agents professional association activities, and other county-wide Extension organizations*) must have at least one Boyd County Extension Agent directly involved in the planning and delivery of educational programs and/or included in agent's plan of work. Agent is not required to be present. All agents will submit annually a listing of groups with officer names that relate directly to their program. There will be no charge for use. A cleaning fee will be assessed by the facility committee if room is not left in an acceptable condition.

II. Boyd County Cooperative Extension Support Groups

Support groups are those organizations outside the umbrella and program definition of Boyd County Extension who are related to its efforts. These could be commodity groups, advisory councils, organizations that have significant or unique ties to Extension. This group must have at least one Boyd County Extension agent directly involved with the organization. Agent is not required to be present. All agents will submit annually a listing of groups with officer names that relate directly to their program. No fee will be assessed. A cleaning fee will be assessed if the room is left in an unacceptable condition. Reservation guidelines in this document apply.

III. Non-Profit Groups

Government and university groups not listed in Group II, and other non-profit groups will be considered by the Boyd County Extension Council Facility Committee, (Clean up, kitchen use, sound system use, etc.). Subject to public meeting room fees.

IV. Business and Industries

Educational and training functions of local businesses and industries will be considered by the County Extension Council Facility Committee, (Clean up, kitchen use, sound system use, etc.). Subject to public meeting room fees.

V. No Private Functions Will Be Allowed

Private functions include (but are not limited to) baby and wedding showers, receptions, family reunions, social affairs, sorority/fraternity function, birthday party, or partisan politics, etc.

Public Meeting Room Fees

Fees may be charged to organizations who are granted use of a room (*see definition of User Groups.*)
These fees partially recover the Boyd County Extension Service's cost of providing these rooms for public use.

FEE SCHEDULE FOR NON-PROFIT AND NON-BUSINESS GROUPS		
Damage deposit of \$100 and meeting room fees are due within 48 hours of approval. The damage deposit will be completely refunded if the meeting is cancelled 14 days prior to the scheduled date or after inspection no damage is noted. If a reservation is cancelled within 14 days of the event a minimum deposit of \$45 will be retained.

<u>KITCHEN USE:</u> A Boyd County Extension trained/authorized manager must be present if kitchen is used. (Two hour minimum) \$45	\$30	\$15
<u>SOUND SYSTEM/AUDIO VISUAL USE:</u> A Boyd County Extension trained/authorized manager must be present if sound or A-V equipment is used. (Two hour minimum) \$45	\$30	\$15
<u>CLEAN UP:</u> Fee charged for use of room, tables, and chairs (NO kitchen or sound system) (Two hour minimum) \$45	\$30	\$15

DAMAGE FEE FOR ALL USER GROUPS

Damages will be assessed per cost of the repair or replacement.
