**Basic Quilt Block Requirements for the
Ohio County Barn Quilt Trail Project**

- ✓ Each block will be 2'X2'.
- ✓ Quilt square may be a pieced or applique pattern.
- ✓ Blocks must be painted on approved signboard or other similar material.
- ✓ Quilt block must be placed on a committee approved barn, building or other location.
- ✓ The quilt block must be approved by the local committee in order to maintain continuity, refrain from duplication and insure quality of the project.
- ✓ The location of the quilt block must be visible from the road for public viewing and not in a location that will present traffic congestion.

**Site agreement for the
Ohio County Barn Quilt Trail Project**

- ✓ I own the property at _____ in Ohio County and hereby authorize the Ohio County Barn Quilt Trail Committee to provide a painted quilt block. The owner will be advised when the block called _____ is ready to be picked up. I agree to allow the Barn Quilt to hang unobstructed or obscured for a period of at least 5 years. I will maintain the view of the block during that time period.
- ✓ If I rent, lease, sell, or otherwise convey my property during this time period, I will notify the Ohio County Barn Quilt Trail Committee to allow them to remove the quilt block if necessary.
- ✓ I will not move or alter the quilt block in any way without first contacting the Ohio County Barn Quilt Trail Committee.
- ✓ I will allow my barn/building to be photographed by the public and photos to be used by the Ohio County Barn Quilt Trail Committee in advertising of the barn quilt trail. I will allow my name or my business's name to be used for advertising materials i.e. newspaper, websites, Cooperative Extension Newsletter, and etc.
- ✓ The Ohio County Barn Quilt Trail Committee as well as its officers, agents, partners, and sponsors will not be held liable against any and all claims, liabilities, losses, and causes of action.
